- Robert Sandman, 77 West Beaver Dr. – applied for hardship variance to have a 30' set back instead of the required 100' setback. Discussion regarding concerns that even the 30' set back would have the building within 35' of wetland delineation line and potential impact to the adjacent wetland.
- AE Stone, Corson Tavern Road and Woodbine/Oceanview Road – mining permit renewal. No objections.
- Roger T. Collins, 153 Corson Tavern Road – applied for hardship variance to have property subdivided with an addition of well and septic. No objections.
